MINUTES OF MEETING HELD ON THE 10th JUNE 1991

MATTERS ARISING FROM MINUTES

1. LAP&TC - Local Government Review The Association had responded to the NALC and a copy of the submission would be forwarded to Parish Councils in due course.

2. Notice Boards Mr W Hill reported that this matter was in hand.

POLICE MATTERS

Inspector D Taylor was in attendance for this item.

Inspector Taylor told the Council that the police had been aware of the problems in the area and had undertaken a lot of activity in the past two weeks. He also said that Court proceedings were pending against a number of youths. Whilst it helped the police to know about incidents so that they could plan operations and put resources to good use, there were occasions when members of the public were needed to give evidence in Court as substantial evidence was needed to ensure a conviction.

Inspector Taylor answered a number of points raised by members of the Council and indicated that 2 people had been reported for motor offences and one person had been fined for a public order offence. The area was no worse than other similar areas in West Lancashire with incidents in the Northern Parishes numbering about the same as those in Burscough. He also explained the difficulties facing the police in taking action on private grounds as the permission of the owner was required due to trespass being classed as a civil and not criminal offence.

The Council were satisfied with the job being done by the local Officer who seemed to know what was happening in the village and it was felt that this was giving the residents more confidence in the police.

The Chairman thanked Inspector Taylor for attending the meeting and for the information given and felt that it was gratifying to know that the police were taking positive steps to reduce and alleviate the problems in the village.

PROVISION OF BRANCH SURGERY IN HESKETH BANK

(Mr K Cuthbertson of the Lancashire Family Health Services Authority was present for this item.)

Mr Cuthbertson explained the policy of the Authority in relation to new proposals and indicated that, in addition to the Parish Council, the Local Medical Committee and the Community Health Council were also being consulted on the proposals by Drs Ebdy and Minshull to site a Branch Surgery in Hesketh Bank. Mr Cuthbertson handed the Clerk a letter which answered the various points as follows:-

Site - None identified as yet.

Facilities available - Surgery sessions, baby clinics, ante natal clinics, vaccination and immunisations.

Just a visiting place - No at least one surgery session there per week,

Minor treatments available - Not at present.

Ante and post natal facilities available - Yes.

Availability of Nurse - The practice employs two practice nurses and one may provide services at the branch.

Computer terminal at Branch - Not at present

Mr Cuthbertson answered questions from members of the Council and indicated that the Authority would initially give approval in principle only and it would be for the Doctors concerned to find suitable premises and obtain any necessary planning approvals etc. Some concern was expressed about the lack of records being available at the branch and it was also suggested that Mere Brow, Holmes and Rufford were in more need of a branch than Hesketh Bank. Mr Cuthbertson indicated that, exclusive use of premises was preferred especially if records were to be kept on the premises.

Mr Cuthbertson also indicated that only one main surgery could be provided for each practice and that the maximum number of patients on a doctor's list was 3,500.

The Chairman thanked Mr Cuthbertson for attending the meeting and for answering the various questions.

It was suggested that as Hesketh Bank was a large and expanding village which had never had the benefit of a surgery, the proposal should be welcomed. There was also an advantage to be had by young mothers and the elderly who currently had the expense of going to Tarleton Health Centre.

Councillors Bannister & Hill left the meeting and it was Proposed and Seconded that the Green Belt line should run behind the houses in Shore Road and straight across Guide Road.
