MATTERS ARISING FROM MINUTES

- 1. The Brow Wall A response was still awaited from the Land Registry.
- 2. <u>Best Kept Village Competition</u> The Clerk reported that permission to use lighting column 55 had been refused because it was due for replacement but column 57 could be used in stead. The brackets had been removed from column 55 and a price for erection on column 57 would be obtained. The hanging baskets had now been placed on the brackets. Also protection for the columns must be inserted prior to next year. Councillor H Tompkins had agreed to undertake watering this year but quotations would be obtained for watering next year.

The baskets outside Top Shop had been raise up and wired and bolted onto the post. Teemac Engineering had inspected the posts and the existing brackets would not fit on the new lamppost by the bridge. Two baskets were currently with Councillor Mrs H Tompkins who was watering the baskets currently on display. It was also reported that the Village Institute was investigating the cost of a video camera.

The trophy won last year was currently with the Rector.

6. <u>Poppyfields Estate – Sewerage & Drainage</u> The District Council had indicated that the drainage on the estate had been supervised by the NHBC and the District Council had no knowledge of the condition of the drains or the supervision provided. A meeting would be held on 29 July to establish the specific works required to bring the sewers upto adoptable standard.

The Clerk was requested to ask the District Council for a report on the outcome of the meeting and to copy the correspondence to the local MP.

- 7. <u>Winter Maintenance in Hesketh Bank</u> Mr Graham Harding, Environment Director of Lancashire County Council had re-iterated the Council's policy as set out in previous letters from his department. The matter was still with the local MP.
- 8. <u>Noise Nuisance in Hesketh Bank</u> The Police were still monitoring the situation and call handling in the Southern Communications Room was improving but still below the standard expected. The District Council had asked the complainant to keep a record of future noise nuisances but had not received further complaints. The matter would be re-opened should further disturbances occur.
- 9. <u>Land adjacent to Becconsall Hotel</u> The Parish Council's latest letter had been passed to the Brewery.
- 10. Access from Becconsall Lane to footpaths 46 & 47 Mr Nairne had provided a list of users of the path and application forms had been received from the County Council. The Clerk was to look if the Council had a copy of the 1950 survey.

- 11. <u>Ribble Catchment Conservation Trust</u> The Council had been accepted for membership and the AGM would be held in November.

INCINERATION OF WASTE

It was reported that it was not the intention of members of West Lancashire District Council to site an incinerator in this area of the district. It was further reported that a

certain landholder had been found to have two industrial incinerators in a barn on his land. It was suggested that the completion of the Green Lane link might facilitate access to an incinerator in Hesketh Bank.

At the present time, Lancashire County Council has a policy of burying waste but new Government Guidelines meant that the amount of waste buried must be reduced. There were currently 3 options for the disposal of waste viz:- recyclable waste, which can be re-used after due processing, green waste, which can be buried, and disposal waste, which would be incinerated. The County Council Policy was for at least one, if not two, incinerators to be provided.

It was agreed to discuss this issue further at the next meeting.
