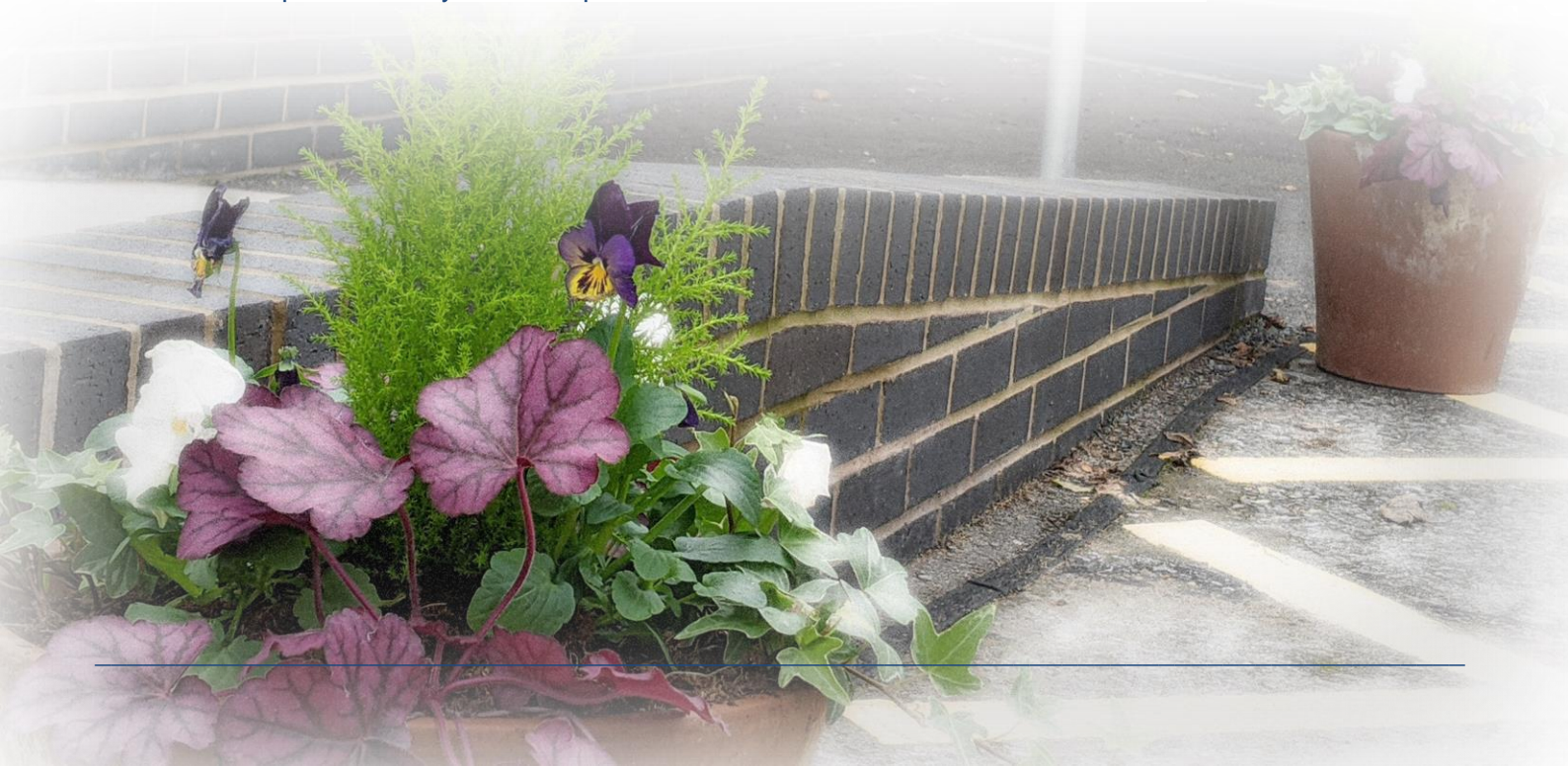

Hesketh Bank came 5th in the Large Village category of the Lancashire Best Kept Village competition this year. Well done to Fish Loves Chips for being 8th out of 21 entries in the Shop category, and the Allotments Peace Garden, which was 5th out of 16 entries in the Public Garden category. The judges said they were “very impressed” with the new Community Centre, which came 7th out of 23 entries in the Public Building category, and once the garden is complete they said it will be a “serious contender”, so watch this space!



Thank you to everyone who sent in nominations for our Love Hesketh Bank Best Kept Competition. Judges, Liz Tyson from Landsdowne Camping and Duncan Taylor from Arden Lea Nurseries, said “It was lovely walking around the village this summer seeing people tend to their gardens with pride.” She continued, “Rose Gardens is beautiful, as always, Cropper Gardens has some interesting and original displays and Poppyfields is much improved, winning the Best Street category, but the street with biggest overall impression is Chapel Road. All credit to the residents, who have significantly upped their game, particularly as it is a very long road with a diverse range of properties.”



Brian and Barbara Bamford from 1 Rose Gardens, who have been runners up twice, finally won the Large Front Garden Category. The couple were thrilled to receive a card from their neighbour congratulating them, which was the first they knew about it. They said they were “very pleased”.



Melanie and Alan Taylor from 8 Moss Lane won the Small Front Garden Category. The couple said it was a “lovely surprise” to receive the certificate and £25 Booths vouchers through their door. It is the icing on the cake for them, as they already have approval from the bees and bugs, who they have worked hard to attract, and they have even had school children knock on their door to say how nice it is. The garden was recognised by the judges for its colour and interest, with ornaments which are there to entertain their grandchildren.
