### **New Defibrillator at Shore Road Pavilion**

Residents of Shore Road and the surrounding streets will be pleased to learn that a new defibrillator has been installed in their area. The defibrillator has been kindly donated by the Douglas Cardiac Trust and has been installed on an outside wall of the changing pavilion located within the Parish Council Car Park beside All Saints CE Primary School at the bottom of Shore Road Recreation Ground.

The Douglas Cardiac Trust have been providing defibrillators at or near public buildings such as schools, church halls and community centres within Hesketh Bank, Tarleton and Banks for over twenty years and have now even started providing them at most large local employers. This latest installation on Shore Road brings the total provision in our area to almost fifty potentially life saving machines. So what if you happen to be around someone who you think may be having a heart

attack? Your first action should be to contact the ambulance service. They can access a national database of all registered defibrillators and will direct you to the nearest one to where you are calling from. Every defibrillator is equipped with clear easy to follow instructions on how to use it on a casualty. However, recognising that many people would worry about dealing with a casualty in what could be a life or death situation, the Parish Council is organising training In how to use a defibrillator in order to encourage people to approach this crucial situation with greater confidence.

If sufficient people are interested in attending this free training, it will be held on Thursday 25th January 2024 at Hesketh Bank Community Centre from 9.00 until 12.00.

## **Minister Responds to Local Flooding Concerns**



On the 2nd of November Hesketh Bank played host to the Rt. Hon Mark Spencer, Minister of State for the Environment along with local MP's Katherine Fletcher and Damien Moore.

This followed concerns about the flooding of 3000 acres of grade 1 farm land on 11th August 2020 which caused 2.5million pounds worth of damage to the farming community and the local economy. It is an area of land that produces some of the finest fresh produce in the United Kingdom.

The National Farmers Union arranged the visit and Westgate Farm, Guide Rd provided the venue, where Local Parish Councillors, Borough and County Councillors and some members of the public sat and listened to presentations given by local farmers, Stan Farrington and James Pope.

The presentations described in detail the historical facts about the drainage and infrastructure of Hesketh Marsh, and the physical damage caused by flooding. They identified the benefits of an IDB (Internal Drainage Board) or Water Management Board while drone footage of the 2020 flood played in the background.

Later a detailed video of 6th Oct 2023 demonstrated the regular failures of the Lancashire County Council Culvert and the overflow of the Carr Heys Watercourse at Dib Rd. Both farmers also highlighted the concerns about increased building developments within the village, creating pollution and an overcapacity of the sewage and surface water infrastructure.

It also provided the opportunity to launch the long awaited Northern Parishes Water Management Document in which this Parish Council has played a significant role. Any future planning and development of our village should now take notice of this professional hydrological report which identifies the responsibilities of each of the authorities, the riparian owners and indeed anyone who has a watercourse or ditch at the end of their garden.

The report was well received by the Minister and we understand from one of the local MPs that it will be high on his list of priorities on his return to London.

### How Do You Like Our New Christmas Lights?

The Christmas Lights were installed across the village on 21 columns to create an impressive Christmas display. The lights were turned on on the 2nd of December, helping to create a very festive atmosphere in the village.



# **Please Do Your Bit to Keep Our Pavements Clear**

Those of us who need to push prams or wheelchairs or use mobility scooters all too frequently need to pick their way along what may be a busy stretch of road in order to get past an obstruction such as a parked car or an overgrown hedge. This clearly puts them at greater risk especially during the darker winter months. In addition, they often find it harder to avoid any dog poo left on the pavement by inconsiderate owners, which can then end up on their wheels. A particular problem for drivers occurs at road junctions when they encounter overgrown hedges and cars parked very close by. This can severely limit their ability to exit a side street safely

Please do your bit by keeping your hedge trimmed, picking up after your dog, parking considerately and, if you do need to park on the pavement, please try to park where you can leave sufficient room for a pram or mobility scooter to get by on the inside of your vehicle.
