## **Chairman's Report 2024**

The present Council has now completed its 3rd and final year in situ. The usual period is normally 4 years, but due to the pandemic there was no election in 2020 so we served for 5 years.

Several members have decided not to stand for election this year. On behalf of the council I would to thank Norma Goodier, Ron Tyson, Louise Taylor and my most recent Vice Chairman Richard Plant for all their hard work and time they have given as members of the council over the many years of service between them.

We were also shocked by the news that David Maughan had sadly passed away just after Christmas and will be sorely missed.

We have one new member who put his name forward and I would like to welcome Ian Eccles to the council. This of course leaves us with 7 members and we can co-opt up to 4 more, although I am aware that one of the above who didn't stand for election is having a change of mind and will be putting their name forward in due course.

The Hesketh-with-Becconsall Parish Council is now split into 2 wards, Becconsall and Hesketh Bank. Myself and Tim Barnacle represent the Becconsall Ward and Ian Eccles joins Joan Witter, Kate Maughan, Steve Kirby & John Hunter to represent the Hesketh Bank Ward.

During the past 12 months The Flooding Committee has continued to push for a joint solution to the problems that have occurred in recent years. Since publishing the Hydrologist's report in November 2023 the committee met with the Rt Hon Mark Spencer MP (Minister of State at the Department for Environment, Food and Rural Affairs) local Borough councillors and representatives from local Parish Councils, the Environment Agency, NFU and the local farming community at Guide Road to discuss the issues we are experiencing. The Northern Parishes Watercourse Review was presented to them and a copy was taken away by the Minister for consideration who is committed to working with us to achieve an effective resolution.

The Persimmon house building site either side of the centre of the village have now extended the Henry Alty Way path through its development. Ian Cropper and his group have done a wonderful job delivering this unique facility for the residents of Hesketh Bank and Tarleton.

As Chairman I thank the clerk, Graham Crompton, and all of the Council past and present for the hard work that they undertake for the whole community within the Parish of Hesketh-with-Becconsall.

# **Update on Flooding**

At the time of writing (mid June) the recent weather has delivered a disappointingly cold and windy Summer on top of a rain sodden Spring. The rainfall we suffered in the early part of 2024 has wreaked havoc within our farming community and caused flooding problems elsewhere within the local area.



Many of you will be aware of the work on Hesketh Out marsh undertaken by the Environment Agency in conjunction with the RSPB over recent years. This involved breaching the outer bank at several points to allow the creation of several lagoons which absorb the incoming sea water at high tide times thus alleviating the threat of tidal surges further inland. This, together with the strengthening of the next embankment inland, was designed to increase the protection of people and property from the possible risk of flooding from the sea due to climate change.

However, little or no action has been taken over recent years to deal with the flooding that occurs further inland due to a combination of increasingly severe rainfall events, burgeoning development and poor maintenance of the drainage infrastructure. This has meant that water coming downstream from the South to the North of our area (i.e. in the direction from Tarleton to Hesketh Bank) is not getting away like it used to in times of severe rainfall events. One of the main reasons for this is that the remit of the Environmental Agency does not include the protection of land - not even Grade One Agricultural Land such as that of our local farmers!

As part of a study into Coastal Management Systems, a workshop was held at Hesketh Bank Community Centre on 6th June focussing on the Hesketh Out marsh. One of the main objectives of the workshop was 'To create a shared understanding of the current coastal management practices in Hesketh Bank and the ways to improve it.' This gave representatives from our farming community and the Parish Council who attended the opportunity to make the case for better protection and to highlight the recent Hydrological Survey that led to the production of the Northern Parishes Watercourse Review, which concluded with a six point plan for a more effective resolution of our flooding problems. The farming representatives were disappointed to note that Lancashire County Council, our Lead Local Flood Authority, were not represented at the workshop.

## **Stop Press!**

It now seems that all the representation that has been made to Lancashire County Council is having an effect: Plans have been announced to undertake drainage repairs and install new drainage at a notorious flooding site near the junction of Shore Road and Dib Road. Sadly this will result in a major diversion of traffic for at least three weeks!
