1. Grass cutting - Verges and Recreation Ground surrounds

It was reported that Mr M Taylor had not responded to a request for a quotation for this work. The Chairman suggested that Brophy's, the District Council Contractor could be approached or failing that Tarleton Parish Council could be asked for details of their Contractor.

RECREATION GROUND AND PLAY AREAS

Station Road Play Area

It was further reported that this brought the total expenditure to £4591.00 + VAT which was £91 over the amount of the grant from the District Council.

The Chairman reported that the performance of Russell Leisure had not been particularly good and at one stage prior to laying the safety surfacing, a concrete surface had been left for 2/3 days. The Clerk also reported difficulty in obtaining the quotation for the additional tiles and the fence.

POLICING IN HESKETH BANK

(PC G Wilson was also in attendance for this item)

Inspector Taylor started by indicating that he was only present because Inspector Norris, who had responsibility for this area, had suffered a broken leg and Inspector Taylor had been brought back to cover the duties.

Inspector Taylor said that it was still the policy for the Detached Beat Officers to attend Parish Council meetings when they received advanced notification that policing matters would be discussed. In this respect PC G Wilson was still working in the area and would deal with matters when on duty. PC Wilson had moved out of the Police House which was being advertised as a detached post but similar advertisements in respect of houses at Banks and Tarleton had not yielded any applicants. Villages had been used to an Officer being on call 24 hours a day, and any calls should now be made to Ormskirk Police Station which was manned 24 hours a day and in radio contact with all patrols. If the matter was urgent then the 999 service should be used. Inspector Taylor apologised that the Council had not been informed that PC Wilson was no longer living in the house.

Mrs N Goodier recounted an incident involving her son when calls to Skelmersdale had not been answered and difficulties had been experienced with the 999 service. Also the police had asked for the injured boy to be taken to Ormskirk Police Station after receiving treatment but he was not in a fit state to make a statement. Inspector Taylor could not answer the specific points raised and felt he would need to talk to Mrs Goodier at another time.

Inspector Taylor said that 4 villages each had their own Detached Beat Officer with additional cover provided by 4 men in a mobile car. The best situation was that 3 Detached Beat Officers and 1 man in the car would be on duty at any one time. He did point out that, although crime was rising, the parish had suffered less than other areas. Additional resources could be brought into the area to deal with specific problems as necessary.

Issues brought to the attention of the Officers included vandalism of the new fence on the Station Road Play Area, under age drinking, speeding through the village and a vehicle parked on the road without a tax disc. The Officers took notes of these issues which would be addressed, although the tax disc offence had been dealt with recently.

In answer to a question as to whether the Officers felt they were being let down by the Courts, it was suggested that some officers were frustrated but the Courts were also under increasing pressure with the prisons bursting to the seams.

The police were trying to encourage more community involvement and urged people to report anything that didn't look quite right. The police lived off information, whether anonymous or not but acknowledged that civilian witnesses were treated badly by the Court system.

The Chairman felt that a useful discussion had been held and thanked Inspector Taylor and PC Wilson for attending the meeting.

It was suggested that the culprits were older children.

RECREATION GROUND AND PLAY AREAS

1. Recreation Ground

a. Proposed new changing facilities The Clerk reported receipt of a letter from the LAP&TC which suggested that the Council could take out a loan for the provision of facilities of this nature or apply to the District Council for a grant. The Lancashire Playing Fields Association may be able to help or the CCL had a Village Projects Fund which gave grants of upto £250 to voluntary organisations. It was felt that the project would not be large enough to qualify for a grant from the Sports Council.

Another meeting had been held between the Recreation Committee and the Boys Football Club and Mr P Bannister had been invited to attend. It was reported that the Club were to apply for planning permission to put the facilities at the top of the bank adjacent to the football pitch and were also looking into the possibility of a grant from the Sports Council. The site preferred by the Boys Club would mean that the swings for the very young children would need to be moved and the Club had undertaken to pay for this to be done.

Mr Bannister had reported to the meeting that the 3 sports clubs using the Station Road facilities were negotiating to purchase the land from the Sports Company subject to a constitution for the future running of the land being agreed by all three clubs. There was also a possibility that the adjacent field could be for sale which could then be utilised to extend the facilities. Mr Bannister felt this was the perfect opportunity for all the sports clubs to come together and perhaps the Parish Council would be willing to purchase the land and act as landlords in the future. The three Clubs were to meet on the 18th September and Mr Bannister would be prepared to seek their views at that meeting.

The Clerk reminded the Council that, at the previous meeting, they had agreed to apply for a Grant for a 'C' Scheme of £30,000 for the provision of changing facilities.

61/92 RESOLVED:- (1) That approval in principle be given to the moving of the young children's swings, subject to the cost of moving, including new safety surfacing, being met by the Boys Football Club,

(2) That approval in principle be given to the proposed site for the new changing facilities adjacent to the football pitch,

(3) That the decision taken at the last meeting to apply for a 'C' Scheme Grant of £30,000 for the provision of changing facilities, be amended in respect of the use for the grant and that the use should be for the purchase of recreational land and/or the provision of changing facilities,

(4) That the Parish Council will pursue the possible purchase of the Station Road Playing Fields subject to the agreement of the Cricket, Football and Bowling Clubs,

(5) That Mr P Bannister be authorised to convey the above decision to the three Clubs and report back their views to the next meeting of the Council.

b. Play Equipment It was reported that new chains and seats had been ordered by Mr M Goodier who would fit them with the help of Mr S Trippier.

c. Use fo Football Pitch Hesketh Bank AFC had applied to use the pitch during the 1992/93 season on a Saturday afternoon for the third team. The reciprocal arrangement with the Boys FC would continue for the season.

62/92 RESOLVED:- That Hesketh Bank AFC be granted use of the football pitch on a Saturday afternoon at a cost of £20 for the season to be paid as soon as possible.

2. Glenpark Drive This issue was still with Mr M Goodier.

3. Station Road

b. Rail alongside Station Road Mrs Trippier and Mrs Kershaw had both priced quickthorn hedging and the quotation obtained by Mrs Trippier was the cheapest. It was suggested 225 plants were required to be planted about 1ft apart. The cost of plants 2' to 3' high was 35 pence each. It was also suggested that some rose bushes should also be planted at particularly vulnerable points.

In the case in question, the ditch was shared by the Parish Council on one side and Mr H Farrington and Mr T Iddon on the other side.

The Committee suggested that the two landowners be approached by the Council and asked to contribute 25% of the cost of cleaning out the ditch with the Council meeting the remaining 50%. The Committee also suggested that, because of a current crop on plot 20, the work be undertaken in the Spring of 1993.

65/92 RESOLVED:- That the recommendation of the Allotments Committee be accepted and the Clerk be authorised to approach the two landowners concerned with a request that they each contribute 25% towards the cost of the cleaning out of the ditch adjacent to Plot No 20 with the Parish Council meeting the remaining 50% of the cost.

TWINNING

The Clerk had received information from the relevant organisation which included guidance on twinning and an application form and it was agreed to ask Mr P Bannister to look at the information and report on the action required at the next meeting.
