and floral planters have all contributed to making Hesketh Bank a much brighter place than it was a few years ago.


Of course this is not to say that certain parts of the village might have gone in the opposite direction in the eyes of some residents (more about this later)

Buoyed by the success of his last campaign, Councillor Ron Tyson has once again accepted the challenge and is determined to do even better this year, helped, as he will be by the three other councillors on the BKVC Committee, Julie Lancaster, Gillian McKean and Steve Kirby.

At their first meeting the Best Kept Village Committee considered the good the bad and the ugly parts of Hesketh Bank and what could be done to improve the blots on the landscape. Some, like the former Becconsall Hotel site will clearly be resolved in time, as will the container on the Shore Road Car Park, currently used as changing facilities, which is due for replacement by purpose built changing rooms. Other areas of blight are more problematical and these will form part of a further report.

As a first step the BKVC is asking for your feedback. We want to know which parts of Hesketh Bank you find attractive and those which you think spoil the look of the village. NEW ENVIRONMENT TEAM IS READY FOR ACTION





From 1 February staff from the Council's Street Scene and Dog control teams will join forces to form one group. This follows a decision taken at Full Council last year in a bid to boost frontline enforcement.

The team will be out on patrol around the borough keeping a watchful eye out for litter louts, fly tippers and dog owners who allow their pets to foul and do not clean it up.

Dog fouling is not only unpleasant it is a health hazard. The biggest problem is toxocariasis, which

can result in infection that lasts up to two years. Symptoms include eye disorders, dizziness, nausea, asthma, seizures and fits and, in extremely rare cases, blindness.

If an owner is caught allowing their dog to foul, they can be issued with a fixed penalty notice, which carries a £75 fine. However, repeat offenders or people who do not pay the fixed penalty notice will face legal action in the Magistrates Court which could result in a £1,000 fine.



People who leave litter behind can also be issued with a fixed penalty notice of £75, and face larger fines if the matter goes to court. Fly-tippers can be fined up £50,000, or face a jail sentence.

Councillor David Sudworth, portfolio holder for Health, Leisure and Community Safety, joined the new team on the beat in West Lancashire.

He said: "It was great to go out on patrol with the team and get a first hand insight on how they work to make West Lancashire as clean as possible.

"Residents quite rightly get very annoyed when they see dog fouling, litter and fly-tipping on our streets, parks and countryside.

"The Council takes these issues very seriously. We have backing from the police who have agreed to work with our new enforcement team, pounding the streets to make sure our borough is kept clean."

To report a stray dog please call 01695 577177. From February 1st the Council will use an outside contractor to deal with stray dogs, a move which will save the authority up to £20,000 while maintaining the same high standard of service. The fee for re-claiming a dog that has been taken in as a stray by the service will remain £85.

PUBLIC CONSULTATION: ALTY'S BRICKWORKS RE-DEVELOPMENT


Alty's are organising a "drop-in event" to be held between 10.00 am and 4.00 pm on Saturday 16th March at All Saints Church Hall, Station Road.

PARISH PLAN REVIEW



It is now more than four years since the Parish Plan for Hesketh with Becconsall was published and so the time is right to conduct a review of the plan to consider how well we have succeeded in achieving the things that you identified as priorities following an extensive consultation exercise in which more than 25% of householders completed survey questionnaires — and of course to see if those things that have not yet been achieved are still relevant, along with any new priorities that you may identify. To undertake a complete new consultation exercise in the same manner as last time would cost more time and money than we think we can justify, given current constraints and the information that we have already

gleaned from the original exercise.

Instead we intend to hold a consultation weekend using Booths as a venue, when we will have a display and presentation and you will get the chance to provide feedback, which will help us to establish our priorities for future action.

The Parish Plan Review weekend will begin at Booths on Friday 19th April from 5.00 p.m. until 9.00 p.m. and will continue on Saturday 20th and Sunday 21st April from 10.00 a.m. until 4.00 p.m. both days.



Please try to pop in and give us your views. They help to provide evidence of need for any funding that we may seek e.g. from the Big Lottery Fund for future projects.

NEW SHOOTS TAKING ROOT

As reported in the last issue, the project to develop the New Shoots Permaculture Site on the Poor Marsh on Shore Road began at the start of January and, after good progress in spite of the winter weather, work is now almost complete. The path for the woodland walkway is finished and, with help from a host of

volunteers during half term week it has now been planted with a variety of fruit trees, bushes and plants. In time these will not only provide a wonderful splash of colour and a fantastic harvest, but they will also be a magnet for a rich diversity of wildlife, as indeed will the pond, wetland and wildflower area which are also complete and planted.

Thanks must go to the contractors Conservation Contracts North West, to Steve Edwards of Lancashire County Council, who has project managed the contract and overseen the whole scheme, to Graham Iddon, who grew the wildflowers from seed and supervised their planting and to the many

volunteers who have willingly and cheerfully given their time.



The site will take a little time to recover its lustre after all the earthmoving works, but a long overdue spell of decent weather during the next few months will make a world of a difference. If you haven't already done so, why not take a walk around your new community garden and then you will be better able to absorb its transformation into what we hope in time will mature into a place that visitors will really enjoy and that local residents will take pride in.

The recently formed management committee of New Shoots is currently recruiting volunteers to help with the development and maintenance of the site.
